- Ishworpur Municipality, Office of Municipal Executive, Ishworpur Sarlahi invites electronic bids from eligible bidders under National Competitive Bidding procedures. Bidding is open to all eligible Nepalese Bidders.

- Bidder must submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). - Pre-Bid Meeting shall be held at Ishworpur Municipality Office, Ishworpur, Sarlahi at **12:00 PM on 18<sup>th</sup> November 2024**.
- Electronic Bids must be submitted through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 PM (19<sup>th</sup> November 2024)**. The office shall not be responsible for any miscommunication in case of incomplete information about the firm's address. Bids received after this deadline will be rejected.
- Bids shall be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM on 19<sup>th</sup> November 2024** at Ishworpur Municipality Office, Ishworpur, Sarlahi. Non-attendance of any or all the Bidders' representatives shall not hinder the opening of the bids. Bids must be valid for a period of as mentioned in table below after the date of bid opening.
- Bids must be accompanied by a Bid Security of minimum amount specified in table below either in the form of bank voucher confirming cash deposit in deposit account no. as specified above or a bid security (unconditional bank guarantee) issued by Commercial Bank or Financial Institution as approved by Nepal Rastriya Bank. The Bid Security shall be *valid for 30 days* beyond the bid validity period.  
**The bidder must clearly quote the contract name and contract number in Bid security form (Bank guarantee) otherwise will cause disqualification of Bidder.**
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Bidders can bid as a single contractor or in the form of Joint Venture of maximum of three contracting firms.
- Bidders are advised to visit the site and assess the actual site condition before submitting the bids at their own cost.
- The employer reserves the right to accept or reject wholly or partially any or all bids without assigning any reason, what so ever.
- Only eligible bidders with the following key qualifications should participate in this bidding:  
**Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 2,67,35,000**  
**Minimum Work experience of similar size and nature: 71,30,000.00**  
Required Bid Capacity: The bidding capacity of the bidder should be equal to or more than the NRs. 1,80,00,000.00
- Bidders are advised to read the bid document and submit the documents required for the submission of bid compulsorily as asked in bid document in proper formats. Failure to do so may result in rejection of the bid.
- Bidders must compulsorily submit the tax clearance certificate of the fiscal years used for calculation of average annual turnover. In case of JV Contracts, tax clearance of JV, JV agreement must be submitted. Failure to submit the same may lead to rejection of bid.
